All goats must have health papers. Mahaska County 4H/FFA members who show in the 4H show will need health papers for the Open Show. Scrapie premise number and ID number for all wether, commercial, percentage, and full bloods must be on health papers. All full blood and percentage goats, except wethers and commercial goats, must be tattooed and tattoos must match health papers.
